- If I accept the care and custody of any animal, the undersigned agrees to release and indemnify and hold harmless Jersey Shore Animal Foundation or any agent representing Jersey Shore Animal Foundation from any cause of action, claim, suit, or demand of any nature whatsoever, including but not limited to any claims of negligence that I or any family member, heirs, agent representatives, executors, administrators and assigns may now have, or may have in the future, against Jersey Shore Animal Foundation on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to any animal the Jersey Shore Animal Foundation has offered for adoption or foster.
